## Specific tasks will include

- Designing and managing both corporate and donor funded projects, ranging from small week-long projects to larger multi-year interventions.
- Delivering against key project requirements such as desktop research, methodology and tool development for field research, training, and developing guides and toolkits.
- Initiating research and presenting findings for projects, proposals, webinars and other platforms.
- Account management of key clients and proposal development.
- + Business development including keeping up to date with upcoming donor opportunities and positioning Partner Africa as a partner for opportunities.
- Managing client relationships and leading meetings with clients, potential clients, and other stakeholders.
- Leading on key internal strategic projects including the development of methodologies.
